MEMORANDUM OF UNDERSTANDING

This memorandum of understanding is made on 1st October 2021 between Tingkhong Gaon Panchayat Tingkhong, Dibrugarh, Assam which is represented by President herein named as First Party and Tingkhong College, Tingkhong, Dibrugarh represented by its Principal herein named as Second Party.

The parties hitherto agree as follows:

(a) The MoU will encourage the following cooperative activities, in particular:

1. Policy dialogue to regularly exchange information and experience on mass education as well as social challenges and to identify priorities for bilateral cooperation in the field of health, education, awareness, capacity building and social mobilization.
2. Exchange and professional development of officials, resource persons, experts, students, faculty and Panchayat workers.
3. Organisation of joint awareness/sensitization programme, capacity building training, exhibitions and symposia on matters of mutual interest. Moreover the parties agree to work together for mass-awareness in respect of sensitive social, educational, and economic issues and will take initiatives for transfer of knowledge in different fields.
4. Arrangement of requisite infrastructure for above mentioned activities as per need of the college and the organisation.

5. Arrangement of Student exposure program, student internship program of the college or exposure program of social training groups of the Panchayat whereby both the parties could be benefited by having access to learning resources in each other's institutions.

6. Maintenance of proper garbage disposal system within the College Campus.

(b) The cost of cooperative activities may be funded as mutually determined. All cooperative activities under this MoU will be subject to the availability of funds of the college and the Panchayat.

(c) This MoU may be amended by mutual written consent of the college and the NGO.

(d) This MoU will remain in effect for an initial period of 5 (five) years and may be extended, on mutual consent, for successive periods spanning not less than one year.

(e) The MoU may be terminated by mutual agreement of both the college and the Panchayat. However, under no circumstances, termination can take place less than one year after it is signed.

Tenure of the MoU:

This agreement is to be in effect at least for three years from the time of endorsement by both the parties.

With a view to promoting cooperation and collaboration in matters relating to education, public-health, environment, capacity building, exposure, social mobilization or other issues and mutual benefit. The areas of collaboration, cooperation and association shall include organisation of project works and internship programme for students, health awareness/sensitization programme, environmental awareness programme, capacity building training, exchange of resource persons, student exposure and related other issues. The primary objectives of this MoU are to facilitate students as well as faculty members of the college and NGO stakeholders to experience social work at and such other activities as are feasible broader platform by sharing knowledge and working together. Further, the MoU will also help the students as well as faculty members of the college and the Panchayat stakeholders through mutual access to resources.
